#### **How it Works**

- 1 COLLECT: Scan Exchange on-prem and Office365, Azure AD, SharePoint and more. Correlate information from HR systems, CMDB's and all other platforms that supply contextual data. SPHEREboard delivers agentless, comprehensive, flexible messaging controls.
- ORGANIZE: Organize ownership across each asset (mailbox, public folder, DL, etc.) and establish use-cases.

  SPHEREboard allows you to catalogue specific assets with VIP Ownership identification alongside associated metadata correlation.
- REPORT: Identify stale/empty assets to reduce the overall size and overhead to manage the environment, examine for open, excessive and non-standard access, and present them in actionable ways.
